**BOARD APPROVAL**—There has been a revision to the GBPOA bylaws; voted and unanimously approved by the board members at the February 3rd meeting, to have a quorum being nine instead of the previous twelve. This will expedite issues to be resolved and/or approved in the future. This will officially be incorporated into the current bylaws.

**GARAGE SALE INFORMATION**—By the rules of application Northfield Township, there are to be no more than **two garage sales per year** by a resident and not extending longer than three days, between 8 AM and 6 PM.

REF: Cook County Code—Appendix A Zoning, Article 4.1.5.

Home owners next to and across the street from garage sale activities are calling and asking for advice as to filing a complaint. They must call the Sheriff and file a complaint. Parking on the grass, preventing passage of other vehicles, and general hazards, can and will be reported.. Give some thought to your parking, do not block a driveway — it may be needed for an emergency. For parties and company, have guests park on ONE side of the street so passage is clear....it's also YOUR vehicle that may get damaged!

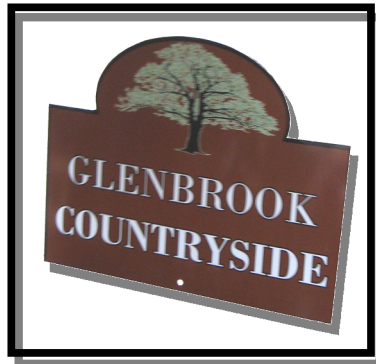
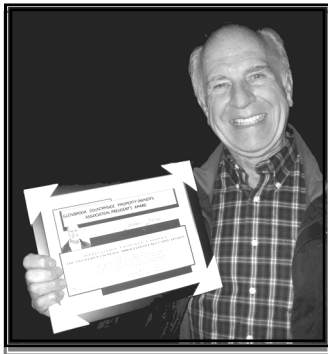
